THIS NECESSITATED A RESTRUCTURING DUE TO MORE MEMBERS RETURNING TO ONSITE PROGRAMMING AND MANAGING STAFF CAPACITIES. IN JUNE 2021, WE CLOSED OUR VIRTUAL PROGRAM AND FOCUSED ON REBUILDING OUR STRENGTH AND PARTNERSHIPS THROUGH THE SUMMER AND INTO THE FALL. WE GAINED SOME STRENGTH IN MEMBERSHIP, CONTINUED TO RESPOND TO ONGOING COVID-RELATED PROTOCOL CHANGES, AND ENDED 2021 FEELING POSITIVE ABOUT OUR PROSPECTS. OUR COMMUNITY-BASED DAY SERVICES, AND OUR ENHANCED PROGRAMS (PLAYMAKERS, ART LINKS WORKS) SHIFTED WITH US FROM MORE VIRTUAL PRESENTATIONS BACK TO IN-PERSON PRACTICES THROUGH 2021. WE FEEL WE ACHIEVED A HIGH DEGREE OF VALUE THROUGH ALL OF OUR PROGRAMS IN 2021, UNDER CONTINUING STRESS
